

# City of Wright City Municipal Court

## Traffic Violations Bureau Fine Schedule

Under authority vested exclusively in the Court by Section 479.050 of the Missouri Revised Statutes and by Rule 37.49 and Rule 38 of the Missouri Court Rules, it is hereby ordered that the following schedule of fines and court costs for the Traffic Violations Bureau be established. This schedule shall supersede all previous schedules of fines and costs whether established by ordinance or otherwise, and shall be applicable only to those violations disposed of prior to the scheduled Court appearance noted on the summons.

It is further ordered as required by Rule 37.49, that this schedule be prominently posted at the place where fines are to be paid. Payment of scheduled fine and costs shall constitute a plea of guilty and waiver of trial. Court costs for each violation shall be as follows:

\$12.00 local court costs; \$7.50 Crime Victims Compensation Fund; \$2.00 Inmate Security Fund; \$2.00 City Police Training Fund; \$1.00 State Peace Officer Training Fund; \$3.00 Missouri Sheriff's Retirement Fund. Total \$27.50

Any violation not listed in this schedule requires an appearance in Court unless otherwise ordered.
