# City of Wright City Board of Aldermen Meeting Thursday, January 25, 2018 City Hall, 203 Veterans Memorial Parkway

Mayor Dan Rowden called the meeting to order at 6:30 p.m. in the Board of Aldermen Chambers of the City Hall, 203 Veterans Memorial Parkway, Wright City, Missouri.

### **Roll Call**

City Clerk Karen Girondo called the roll with Mayor Rowden, Alderman John O'Connor, Alderman Kerry Lambright, Alderman Nathan Rohr and Alderman Thomas Dixon present. Randy Deatherage, Kenny Robinett of the public works department, Parks Director Curt Kehoe, City Attorney Paul Rost, Police Chaplin Joseph Purl and Police Officer James Heppermann. Others present were John and Shirley Riggs, John and Simeen Cook, Pat Janish, Wayne Nolting, Patsy Jones, James Logan, Dwayne Paul, Randy Lewis and Adam Rollins of the Warren County Record.

Mayor Rowden asked Mr. Janish to lead the Pledge of Allegiance.

## **Approval of Minutes/Financial Reports**

Alderman Dixon moved and Alderman O'Connor seconded the motion to approve the minutes of the January 11, 2018, Board of Alderman meeting. On voice vote, the motion was approved 4-0. Ms. Girondo reported the December financial report has not been completed.

#### **Open Meeting to Public Comments/Concerns**

Mr. Nolting asked if the City had the property at 793 Westwoods Road it proposes to purchase for a city park appraised and if the City had considered an alternate site on Westwoods Road for a city park. He also questioned why the City planned to use a portion of the proceeds from the proposed sale of the municipal water and sewer systems for a park. ### **Old Business**

Wright City Municipal Project Status Report – Mr. Schuchmann said both the building inspector and fire department inspector have approved installation of the drywall in the aldermanic chambers of the new city hall. He said he is seeking plumbing and electrical bids for the remodeling project.

**Water Hookup Request – John Cook –** Mr. Cook presented the utility easements he has received from property owners that would permit him to run a water line from the City's water main to his property. He requested permission from the Board of Aldermen to connect his property, located outside the city limits at 29131 North Stringtown Road, onto city water. Alderman Rohr moved and Alderman Dixon seconded the motion to permit John Cook to hook onto the City's water main for his property at 29131 North Stringtown Road. On voice vote, the motion was approved 4-0.

**Cemetery Mowing** – The Alderman asked Ms. Girondo to prepare bid specifications for the mowing of the city cemetery and any other required services to the cemetery grounds.

#### **New Business**

**Strassenbash Parade** – **Brad Schuster** – The Aldermen tabled a request from the Wright City Area Chamber of Commerce for a special permit to close a portion of Bell Road and Westwoods Road for the Strassenbash parade September 15, 2018.

Park Board Members Term Approval – Mayor Rowden recommended John Lacaillade and Patsy Jones be appointed to two-year terms on the Park Board and Mary Long be appointed to a one-year term. Alderman O'Connor moved and Alderman Lambright seconded the motion to accept the Mayor's recommendation and appoint John Lacaillade and Patsy Jones to two-year terms on the Park Board and Mary Long to a one-year term. On voice vote, the motion was approved 4-0.

**Salt Bids** – Mr. Janish presented bids for the purchase of 822, 50-pound bags of salt. The bids are: JBC Transport, \$3,330.00; Wright City Hardware, \$4,411.08; T&N, Inc., \$3695.70. Mr. Janish recommended acceptance of the JBC Transport bid. Alderman Rohr moved and Alderman O'Connor seconded the motion to accept the bid of \$3,330.00 from JBC Transport. On voice vote, the motion was approved 4-0.

Water Hydrant, Piping and Accessories for 1323 Veterans Memorial Parkway – Mr. Janish presented three bids for the purchase of a hydrant, piping and accessories for utilities at 1323 Veterans Memorial Parkway. The bids are: Schulte Supply, Inc., \$3,673.23; Boehmer Brothers Utility Supply, \$3,803.75; and Core&Main, \$3,615.90. Mr. Janish recommended acceptance of the Core&Main bid. Alderman Dixon moved and Alderman Rohr seconded the motion to accept the bid of \$3,615.90 from Core&Main. On voice vote, the motion was approved 4-0.

**Sidewalk Request 407 Fredricksburg Way** – The Aldermen reviewed a written request from the resident at 407 Fredricksburg Way to construct a sidewalk on the property owner's side of the street from the home to the bus stop.

City Hall/Treasurer/Economic Development – Ms. Girondo reviewed highlights of her written report. She reported the City's new website is up and running, however, revisions and additions to the site are planned. She also reported she has received several inquiries from persons looking for industrial/commercial buildings.
