#### **Approval of Minutes**

Mr. Lambright moved and Mr. Schroeder seconded the motion to approve the minutes of the February 20, 2018, Planning and Zoning Commission meeting. On voice vote, the motion was approved 7-0.

### Old Business/Recommendations to the Board of Aldermen

**Comprehensive Plan Update** – Ms. Girondo said work on the comprehensive plan update by the Booneslick Regional Planning Commission should begin in April.

## New Business/Recommendations to the Board of Aldermen

Site Plan for Lot 15 Gateway West Industrial Centre – Mr. Young, property owner of Lot 15 and A.J. Girondo of the engineering firm for the property submitted a site plan for the development of the Lot. Mr. Young said the plans include the construction of two buildings, however, only one building will be constructed during the initial phase of development, he said. The second building will be constructed when it is economically feasible, he said. Mayor Rowden moved and Mr. Iannicola seconded the motion to approve the west half of the site plan for the construction of the first phase of the project and require the property owner to submit a site plan for the development

of the remainder of the property when the property owner is ready to build. On voice vote, the motion was approved 7-0.

**Site Plan for 201 North West Avenue** – Ms. Hill presented a site plan for the development of the property at 201 North West Avenue as an office building for her insurance agency. She said the existing parking area will be widened and street parking will also be utilized. Ms. Hill said her business will take occupancy of the structure May 1 and requested she be given until June 1 to have the parking area enlarged. Mayor Rowden moved and Mr. Iannicola seconded the motion to approve the site plan for 201 North West Avenue as presented and to allow the property owner until June 1 to have the parking area upgraded. On voice vote, the motion was approved 7-0.

**Upcoming Projects** – Ms. Girondo asked the Commissioners who should be the contact person regarding grading site plans for prospective projects. The Commission said such questions should be directed to Mr. Schuchmann.
