City of Wright City Board of Aldermen Meeting Thursday, March 28, 2019 City Hall, 636 Westwoods Road

Mayor Dan Rowden called the meeting to order at 6:30 p.m. in the Board of Aldermen Chambers of the City Hall, 636 Westwoods Road, Wright City, Missouri.

Roll Call

City Clerk Karen Girondo called the roll with Mayor Rowden, Alderman Nathan Rohr, Alderman John O'Connor, Alderman Thomas Dixon and Alderman Kerry Lambright present. City staff present were City Clerk/Treasurer Karen Girondo, City Administrator James Schuchmann, Public Works Superintendent Kenny Robinett, Police Chief Matthew Eskew, Parks Director Curt Kehoe, City Attorney Paul Rost, Abbie Ogborn, Municipal Division Clerk Marie Hollenbeck, Police Chaplain Joseph Purl and Officer James Hepperman. Others present were Laureen Hoffman, Dave and Ruthie Jayne of Green Wellness, Randy Lewis of Country Tyme Realty, William Johanning, Scott Schroeder and Adam Rollins of the Warren County Record

Pledge of Allegiance

Mayor Rowden led the Pledge of Allegiance.

Approval of Minutes and Financial Reports

Alderman O'Connor moved and Alderman Dixon seconded the motion to approve the minutes of the March 14, 2019, Board of Alderman meeting. On voice vote, the motion was approved 4-0. Alderman Dixon moved and Alderman O'Connor seconded the motion to approve the January and February financial reports. On voice vote, the motion was approved 4-0.

Responses to Previous Comments/Concerns

Open Meeting to Public Comments/Concerns

Ms. Hoffman, a resident of Ruger Court, asked the Board to consider posting a "street not thru" sign on Ruger Court. She said motorists drive down the dead-end street and some drive through her yard to turn around. She also said repairs to the road are needed at the entrance to Dollar General from the North Outer Road and on Elm Avenue at the cemetery entrance and Phillips 66. Mayor Rowden said officials would review the concerns. Ms. Jayne introduced herself and said her company is interested in opening a medical marijuana dispensary in Wright City and said she looked forward to working with city officials and complying with any city requirements.

Recommendations from Planning and Zoning Commission

Resubdivision of Land West of Hat Trick Lane – Ms. Girondo reported the Commission recommended the Aldermen approve the proposed resubdivision of the tract. Mayor Rowden said a proposed ordinance approving the resubdivision is on the agenda for consideration at this meeting.

Old Business

Wright City Municipal Project Status Report – Mr. Schuchmann presented costs for the purchase and installation of a generator for City Hall. The total cost is \$20,810.00. Mayor Rowden recommended the Aldermen approve the purchase and installation of the generator from vendors CK, Don Meyer Electric, GMP and Ameren. Alderman O'Connor moved and Alderman Dixon seconded the motion to approve the purchase and installation of a generator for City Hall. On voice vote, the motion was approved 4-0. Mr. Schuchmann reported the environmental inspection revealed no asbestos tile at the former city hall building, however, some substance was found in a glue used on a small portion of the tile. He said if the glue is not disturbed, it will not need to be removed, however, he suggested removal of the material. He said he will obtain bids for the removal of the glue substance.

PWSD #2 Easements – Alderman O'Connor moved and Alderman Rohr seconded the motion to table a request by the public water supply district for a sewer main easement on the property the City recently purchased on Westwoods Road for development as a city park.

New Business

Lions Club Liquor License – Alderman Rohr moved and Alderman Dixon seconded the motion to approve liquor licenses for the Wright City Lions Club to operate a beer stand at the community fireworks display June 29, 2019, and two beer stands at the Strassenbash September 20 and 21, 2019. On voice vote, the motion was approved 4-0.

Real Estate Contract Extension – Mr. Lewis said the City's listing contract for property located at 13230 Veterans Memorial Parkway is scheduled to expire. Alderman Dixon moved and Alderman O'Connor seconded the motion to approve an extension of the contract with Country Tyme Realty, LLC to October 30, 2019. On voice vote, the motion was approved 4-0. Veterans Memorial Parkway – Mr. Schuchmann said some sidewalk repairs are needed along Veterans Memorial Parkway. MoDOT only maintains the driving lanes of Veterans Memorial Parkway, he said. The shoulder and sidewalks are the responsibility of the City.

Show-Me Courts – Ms. Hollenbeck reported the Municipal Division is scheduled to begin using the state-wide case management system known as Show-Me Courts May 1, 2019, and said an ordinance authorizing the city clerk to sign an agreement with the Office of State Courts Administration and levying an additional \$7.00 in court costs for court automation is on the agenda for the Board's consideration.

Cemetery South Boundary – Ms. Hollenbeck said the Cemetery Memorial Society is planning priority projects for the cemetery and among the projects is improving the boundary between the cemetery and Midwest Petroleum (property owner is Rick Fowler). She said the brush along the eastern boundary now serves as a buffer and barrier between the business and the cemetery, however, it is unsightly, and litter from the business blows onto the cemetery property. She suggested a privacy fence would serve as a better barrier. Mr. Schuchmann suggested the City obtain a survey of the area to determine the property lines. Alderman Dixon moved and Alderman O'Connor seconded the motion to contract with Lewis and Bade, Inc. for a survey of the cemetery and Fowler property line. On voice vote, the motion was approved 4-0.

Intergovernmental Cooperation Agreement with Wright City R-2 School District – The Mayor said a Resolution is on the agenda approving an agreement that allows the school district

to use city equipment under the operation of a city employee and sets forth the hourly rate for the equipment and the operator.

Police – Chief Eskew asked the Aldermen to consider the use of the software program Leads on Line to assist the department in its investigations. The program cost for three years is \$1,410.75 the first year and \$1,881.00 the remaining two years. Mayor Rowden recommended the City enter into a three-year contract with the company. Alderman Dixon moved and Alderman O'Connor moved the City approve a three-year contract with Leads on Line. On voice vote, the motion was approved 4-0. Chief Eskew reported he expects delivery of the recently purchased police vehicles in the next week. He also complimented the K-9 unit on its assistance with the recent search for a Marthasville girl. Mayor Rowden congratulated the police department on the City's recent ranking by Safewise as the sixth safest city in Missouri.

City Hall/Treasurer/Economic Development – Ms. Girondo reviewed highlights of her written report and said she has begun work to update the municipal code.

City Administrator – Mr. Schuchmann said a Resolution with ARC Pyrotechnics, Inc., was inadvertently omitted from the agenda, and he asked the Aldermen to amend the agenda and add Resolution R9-19. Alderman Dixon moved and Alderman O'Connor seconded the motion to amend the agenda and add Resolution R9-19.
