Osage Fund LLC Zoning Change Ag-1 to "PDA" – Mr. Girondo opened the hearing on an application filed by Osage Fund, LLC to rezone approximately 40 acres at Bell Road and Westwoods Road from AG-1 to Planning Development Area. Ms. Blackstun, a resident of 146 Quail Creek Drive, said she was concerned about the potential highway noise that could exist with commercial development of the property, and the effect the development may have on wildlife. Mr. Cusumano, a resident of 158 Quail Creek Drive, said he would like the natural buffer of trees and shrubs that now exists between the site and the Quail Creek Subdivision to be preserved. He also asked if a retention pond is planned. Commission members said these matters would be determined when any plans for development of the property are designed. Hearing no further comment, Mr. Girondo closed the hearing.

Conditional Use for Home Occupation at 509 Wild Oats Drive – Mr. Girondo opened the hearing regarding an application filed by Gregory Savoie seeking a conditional use permit to operate a home office for his business GRS Logistics, LLC at 509 Wild Oats Drive. Hearing no comments from the public, Mr. Girondo closed the hearing.

On voice vote, the motion was approved 5-0.

Subdivision Plat Changes – Mr. Girondo moved and Mayor Rowden seconded the motion to recommend the Board of Aldermen approve changes to the subdivision ordinance and application. On voice vote, the motion was approved 5-0.
