Reports

Parks – In the absence of the parks director, there was no report.

Public Works – Mr. Schuchmann reported employees have repaired the area around LouisianaQ and removed concrete from areas at the former city hall building.

Police – Chief Eskew reviewed highlights of calls, incidents and arrests handled by the Department. He said Off. Nick Bone began employment with the Department October 10. He reported there were no issues with the recent band festival, Faith Fest or the Fall Festival. Chief Eskew said Off. Daniel Jarvis has satisfactorily completed his probationary period. Alderman Dixon moved and Alderman Rohr seconded the motion to increase Off. Jarvis' hourly pay to \$20.00 per hour. On voice vote, the motion was approved 3-0.

City Hall/Treasurer/Economic Development – Ms. Girondo reviewed highlights of her written report. She said she continues work on the proposed 2020 budget and is also updating the City's policies and procedures manual.

City Administrator – Mr. Schuchmann reported the contractor is waiting on documents from the bonding company before it begins work on the East First Street South project. He said a meeting with the engineers on the park project is planned for October 24. He said he will attend right-of-way training sponsored by MoDOT October 16 and 17. Ms. Ogborn and Stephanie Hampton will attend computer training sponsored by Gworks Nov. 4 and 5 in Farmington and Denise Queen will attend training Nov. 6 and 7 in St. Roberts.
