Mayor Rowden, called the meeting to order at 6:30 p.m. in the Auditorium of the City Hall, 636 Westwoods Road, Wright City, Missouri. The meeting was available to attend via Zoom.

Roll Call

Mayor Rowden asked Joshua Cole to lead the Pledge of Allegiance.

Approval of Minutes

Alderman Lambright moved and Alderman Heiliger seconded the motion to approve the minutes of the August 13, 2020, Board of Aldermen Meeting. On voice vote, the motion was approved 4-0.

Responses to Previous Comments/Concerns

Mr. Schuchmann provided responses to questions that had been asked by Justin Crady at the previous Board of Aldermen's Meeting.

Open meeting to Public Comments/Concerns

Donald Andrews asked if there were any plans on adjusting the annual budget for the Parks Department to have enough money to operate without ending negative each year. Mayor Rowden said in October the City will begin looking at the Budget for next year and what the City has to work with. Mr. Andrews asked how the Trunk or Treat event was going to be handled and at this time there is no change in plans.

Public Hearing

2020 Tax Rate - Mayor Rowden opened the Hearing to here public comments on the proposed Tax Rates for 2020. Mr. Andrews asked who set the tax rates and Mr. Schuchmann said the formulas are set by the State and were originally voted on in the 1980's.

Old Business

Wright City Municipal Project Status Report – Mr. Schuchmann reported the Police Department had been occupying Phase 1 for two weeks and everything is working smoothly. The back up generator has been installed and additional office furniture has been delivered.

New Business

Payment Agreements – A list of two payment agreements approved by City Administrator Jim Schuchmann, was reviewed by the Board of Aldermen as part of the Payment Agreement Policy. Alderman Hakim moved and Alderman Lambright seconded the motion to accept the Payment Agreement report. On voice vote, the motion was approved 4-0.

MCHCP Medical, Dental and Vision 2021 – Alderman Hakim moved and Alderman Rohr seconded the motion to accept the recommendation and approve the PPO 750 Health Plan. On voice vote, the motion was approved 4-0.

Cemetery Trees – Mr. Schuchmann presented the Board with a quote from Hoette Farms and Nursery, Inc. for Fall Treatment on nine declining Oak Trees and one Sugar Maple Tree in the City Cemetery. The cost of the treatment would be \$5,500.00 and due to our insurance, several bids will need to be submitted. No motion was made.

Surplus Equipment to sell – The Board was presented a list of equipment from several departments that are no longer in use and that they would like to sell. Alderman Rohr moved and Alderman Hakim seconded the motion to accept the list and have City Staff post for sale. On voice vote, the motion was approved 4-0.

Chamber of Commerce light pole decorations – The Wright City Chamber of Commerce would like to decorate light poles along the Parade Route for Strassenbash. Mr. Schuchmann presented a list of rules and specifically asked for no political signage due to the light poles being City Property. Alderman Lambright moved and Alderman Rohr seconded the motion approving the light pole decoration rules. On voice vote, the motion was approved 4-0.

Parks – Mr. Cole reviewed highlights of his written report including upcoming events, progress on the diamond 1 ball field and stated that Woofstock was a huge success. Mr. Cole said fall soccer games will start on Saturday, September 5th and thanked all the organizations who were able to sponsor kids who were unable to afford the fee.

Public Works – Mr. Roettger said future projects such as sidewalks, concrete pads and entrances to subdivisions were in the works for the department.

Building Official – Nothing to report.

Police – Lieutenant Canavan said the department has been very proactive. Officer Malta will complete K9 training at the end of the week and the department is getting settled into Phase 1.

City Hall – Ms. Ogborn said the City-Wide Yard Sale is Saturday, September 26^{th,} and asked residents to register by September 3rd to be listed in the Warren County Record.

Treasurer – Ms. Hampton asked if City Staff could begin issuing refund checks following a park reservation so the deposit is returned in a timely fashion. A report of these refunds would be presented at the next Board Meeting. After discussion, a written policy would be best and at this time, City Staff is to continue current procedure.

City Administrator – Mr. Schuchmann said things are running along and looks forward to addressing future projects in the City.
