<u>Fireworks</u> – The city fireworks display will be held at the Wright City Lions Club on Saturday, July 3<sup>rd</sup>. Discussion was held on donations/sponsorships of the event.

<u>Westwoods Rd. Supplemental Engineering</u> – GBA presented a request for supplemental work to address a property owner's concerns about an existing drainage problem. Alderman Hakim moved and Alderman Rohr seconded the motion to approve the supplemental agreement in the amount of \$4,758.00. On voice vote, the motion was approved 4-0.

Mr. Schuchmann stated his top four were Bartlett&West, GBA, Lochmueller, and EFK Moen. Alderman Hakim stated his top four were Bartlett&West, GBA, HDR, and Lochmueller. Mayor Rowden stated his top four were EFK Moen, GBA, Bartlett&West, and HDR. Alderman Heiliger moved and Alderman Hakim seconded the motion to invite Bartlett&West, GBA, HDR, and Lochmueller for interviews on Wednesday, April 7<sup>th</sup>, 2021 at 6:00 p.m. On voice vote, the motion was approved 4-0.

**Frank Ellis Car Show** – Frank Ellis expressed concerns regarding the new park fees and asked for help providing amenities. The car show is scheduled for July 31, 2021.

Wreaths Across America – Alderman Hakim moved and Alderman Heiliger seconded the motion for Wreaths to be placed in our City Cemetery on December 18<sup>th</sup>, 2021. On voice vote, the motion was approved 4-0.

**City Administrator** – Mr. Schuchmann said the workman's comp premium payment is due by March 20<sup>th</sup> and has yet to receive a second quote. Alderman Hakim moved and Alderman Heiliger seconded the motion to make the payment of the current quote we have or the better of the two if the additional quote is received. On voice vote, the motion was approved 4-0.
