By signing this application, the Petitioner(s) hereby states as follows:

1. That the petitioner(s) is the owner of all fee interests of record in all tracts of real property located within the area proposed to be annexed described in "Exhibit A" attached hereto and made part of this Petition by reference (the "Property").
2. The Petitioner(s) request(s) that the Property along with all adjacent rights-of-way be annexed to, and included within the corporate limits of, the City and that the Board of Aldermen of the City to adopt an ordinance extending the limits of the City to include the Property.
3. The Property is in an unincorporated area of Warren County, Missouri, which is contiguous and compact to the existing corporate limits of the City of Wright City, Missouri.
4. That the annexation of the Property is reasonable and necessary to the proper development of the City of Wright City and the City will be, within a reasonable time after such annexation becomes effective, able to furnish normal municipal services to the Property.

We request that the City's Board of Aldermen schedule and hold a duly noticed public hearing concerning this Petition (the "Public Hearing"), and, upon conclusion of the Public Hearing, make the determinations required by law and adopt an ordinance extending the City's corporate limits to include the Property.
