Parks – Sport programs are going well. The Bike and Book It event will be May 20th. The Flag Retirement Ceremony will be June 10th and the department is looking for speakers. The sign at Diekroeger Park will be replaced after a car hit the sign during a car accident.

Public Works/Director of City Services – Materials are being gathered to seal the roads in the Forest Lakes Subdivision. The sidewalk project at Westwoods Road and Indian Head Lodge Road will begin after school is out for the summer. The parks department facilities have received new door locks. Mr. Roettger will provide an updated road priority list.

Building Official – Mr. Godier provided an update on the residential and commercial construction.

Police – The department has received SRO applications. The Chief will be meeting with Dr. Way to set up interviews over the next few weeks. The United States Deputy Sheriffs Association has granted the department a small, inferred camera. Officer Malta has begun the 6-week K9 program in Michigan and has selected an 18-month-old German Shepard. K9 Athena will be retired within the next few weeks.

City Hall – Liquor License renewals have been sent out. Those who volunteered, worked, or donated towards the City Wide Clean up day were thanked. The Planning and Zoning meeting for May 15th has been cancelled.

Treasurer – Preparations for the Audit report, tax rate, and 6-mo financials are underway. The Work Comp audit went well.

HR/Payroll – Officer James Auer was welcomed to the city. Gail Wesley, Thomas Canavan, and Joseph Chadd were acknowledged for their years of service to the city.

Mayor Heiliger would like the Board to review internal reports being created within the city to remove unnecessary reports.
