Director of City Services – The department has completed asphalt projects citywide. New banners have been hung in the downtown district. Preparations for the sidewalk project at Indian Head Lodge Road and Westwoods Road have begun. Mid Rivers Asphalt began working on Stuermann Road. Due to the street not having striped lines prior to re-surfacing, Alderman Hakim recommended to allow the asphalt to settle before striping the road.

Building Official – Mr. Godier provided an update on the residential and commercial construction. The sidewalk along Bell Road near the Vista on the Park development was redone. The city has received inquiries on code requirements from Dominos Pizza.

Police – Athena has been retired from the department. Officer Malta has begun training with the new K9 dog and will be done the week of July 14th.

City Hall – Sweetens Sealing Services, LLC received a business license. Ms. Ogborn has been fielding a lot of calls from developers looking to come into the city.

Treasurer – Ms. Hutchings has been providing the auditors with information for the audit. The report is due to the State Auditor on June 30th. Preparations for the 6-month financial statement and tax rate are underway.

HR/Payroll – There was nothing to report.
