Parks – Stuart Bruning was introduced as the new Parks Director and plans to start on July 17th. Kathy Kehoe thanked the Board and is excited to see Mr. Bruning pack in the parks.

Director of City Services – The department finished lining the ditch along Stuermann Road with rock. Work has begun at the corner of Indian Head Lodge Road and Westwoods Road. Baseball season has concluded and Mr. Roettger plans to schedule the manhole cover work with PWSD #2. The department was thanked for their help with the First Friday events.

Building Official – Mr. Godier was available via zoom and provided an update on the residential and commercial construction. Wright Construction gave the city staff a compliment during a school meeting.

Police – A selection of Officers have begun taking over Code Enforcement and have created a log system. Officer Malta will be concluding his K9 training within the next few weeks. Aaron Sutton was announced as the new Lieutenant and will start on July 17th.

Alderman Owens was available via zoom at 7:03 p.m.

City Hall – Continuing to work on the National Night Out event, plan review, and 62-acre park documents.

Treasurer – Ms. Hutchings had been preparing the 6-month financial and will have it published in the Warren County Record.

HR/Payroll – Ms. Queen was not present and there was no discussion.

The walk-in cooler structure is up and waiting for connection. The Board attended a MODOT I-70 update meeting and another meeting will be held in October in Warren County. Saturday, July 15th is Summer Splash at Diekroeger Park. August 4th is Back to School theme at First Friday.

Final Questions

Sarah Schroeder reviewed the city's comprehensive plan and stated that a need in our community is a civic center and believes the 62-acre park is the ideal location. Ms. Schroeder expressed concern with a lift station near her home that is being raised. Ms. Ogborn stated that PWSD#2 received a variance for that work to be completed.
