# City of Wright City Board of Aldermen Meting Thursday, February 27, 2025 City Hall, 636 Westwoods Road

### **Public Comments**

## **Public Hearing**

Amending Section 405.110 of Chapter 405 relating to off-street parking and loading requirements - Mayor Heiliger opened the hearing for comments relating to the proposed amendments to Section 405.100 relating to dumpsters and grease traps for commercial districts. There being no comments, Mayor Heiliger closed the hearing.

Repeal Article IV of Chapter 405 relating to a placeholder Planned Development Areas (PDA's) - Mayor Heiliger opened the hearing for comments relating to the repeal of Article IV relating to Planned Development Areas (PDA's). It was stated that this section was simply a placeholder for future legislation but has since been placed in a different chapter of the code. Repealing this section will not remove any legislation. There being no comments, Mayor Heiliger closed the hearing.

Amending Chapter 405 relating to signs in all zoning classifications - Mayor Heiliger opened the hearing for comments relating to the proposed amendments to Section 405.100 relating to signs. There being no comments, Mayor Heiliger closed the hearing.

# **Recommendations from Planning and Zoning**

**Wright City Dental Site Plan – Wildcat Drive** – The Board reviewed planning and zoning's recommendation and approval of the Wright City Dental office site plan that will be built along Wildcat Drive. This was just for informational purposes and required no further action by the Board.

#### **Old Business**

**Roelker Road Update** – Five trees located at the intersection of Roelker Road and West Second Street North will be removed. Public Works staff will continue to address the rock patches. City staff will work to create the bid packets for the widening and overlay of Roelker Road that will include guardrails, painted crosswalks and lines, and widening 3 lanes in front of the highschool that will include a designated turn lane.

### **New Business**

**Grant Proposal – Cops Hiring Grant** – The city was awarded the COPS hiring grant in 2024 in the amount of \$377,000 to bring on 3-additional officers. This grant will run consecutively and be able to keep the three hired officers on staff for an additional 3 years. Alderman Hakim moved to accept the grant proposal as submitted. Alderman Owens seconded the motion and the voice vote was as follows:

# Reports

**Parks** – American Red Cross held a blood drive on February 20<sup>th</sup>. Facility rentals are filling up quickly.

**Public Works** – The department addressed another winter weather storm and installed new springtime banners in the downtown district. New speed limit signs and railroad crossing sings have been installed on Roelker Road. The department is working to evaluate roads city wide that need repaired.

**Building Official** – Autozone is looking to purchase the old dollar general building. A drywall company has inquired about building along Highway H. Ivie League Homes has submitted 10 building permits.

**Police** – New furniture will be installed the week of March 5<sup>th</sup>. Detective Sergeant Holmes hosted a presentation for the cub scouts.

City Hall – Meet the candidate night is scheduled for April  $3^{rd}$  at the High School Library. The city wide yard sale is May  $17^{th}$  and May  $18^{th}$ . Large item pick-up is June  $2^{nd}$ .

**Treasurer** – There were no questions for Ms. Pohl.

DUB-C explorers will host a bingo night on April 12<sup>th</sup> to raise money. Blue and Gold is March 15<sup>th</sup>. Backstoppers raised \$150,000 prior to paying bills.

Jack Underwood asked if Roelker Road would consume all of the 2024 GO Bond funds or if other street projects would be completed. Rod Smith, resident of Forest Lakes, wants to ensure that the city chooses the best contractor to compete the work on Roelker Road.
