City of Wright City Board of Aldermen Meting Thursday, March 27, 2025 City Hall, 636 Westwoods Road

Mayor, Michelle Heiliger called the meeting to order at 6:30 p.m. in the Auditorium of the City Hall, 636 Westwoods Road, Wright City, Missouri. The meeting was available to attend via Zoom.

Roll Call

Financial Reports

Mayor Heiliger informed the Board that the 2024 Budget Document was sent out for their review. Two corrections needed to be made to the document: move \$7,500 in general revenue to the parks revenue from the sale of two tractors and make a correction to the December 2024 tax bill distribution.

Mini Excavator Lease – The Public Works department was allocated funds in their 2025 budget to lease a mini excavator. Mr. Roettger informed the Board that they will lease a John Deere 60P Mini Excavator from Sydenstricker Nobbe for 4 years that has a 2-year full warranty on the entire machine. At the end of the lease, the city will have the opportunity to purchase the equipment outright or enter a new lease with a newer machine. Attachments are available that the department may utilize.

Workman's Compensation Renewal Provider - The city received the workman's compensation renewal quote earlier in the week in the amount of \$125,538.00, nearly double than 2024. Staff contacted Scott Agency, Inc who is the policy holder for all other city insurances, who was able to provide a quote at the same cost. Alderman Hakim moved to accept the quote from Scott Agency, Inc and to move the workman's comp policy to their company. Alderman Owens seconded the motion and the voice vote was as follows:

Parks – The first annual wildlife exhibit was held at Liberty Christian Academy with over 250 people attending. 177 kids are signed up for baseball and softball. Easter Egg hunt is April 26th.

Public Works – The department is continuing to address Roelker Road and will be going out for bid to patch rock patches along the roadway next week. Once concept plans are submitted to the city for the widening and overlay of Roelker Road and are approved by the Board, the engineered construction plans will be drafted and advertised for bid.

Building Official – There has been no movement on the previously approved strip mall at Roelker Road and Veterans Memorial Parkway. Autozone has inquired about building permits. A mobile home at West 2nd Street and Roelker Road is in the process of changing ownership and staff is working with the sellers agent on a punch list of items the new buyer would be responsible to complete.

Police – Three new Police Officers are completing field training. Officer Parkinson has been released to full duty allowing the department to be fully staffed. The annual Flock Camera report was provided to the Board.

City Hall – There were no updates to provide.

Treasurer – There no updates to provide.
