# **Public Hearing**

<u>Amending Chapter 410 relating to Sidewalk Requirements</u> – Mayor Heiliger opened the public hearing for comments relating to proposed amendments to Chapter 410. There being no comments, Mayor Heiliger closed the public hearing.

<u>**Rezoning 0.77 ± acres from C-4 Commercial to MR-2 Multi Family Residential**</u> – Mayor Heiliger opened the hearing for comments relating to a rezone petition from Myers Select Homes. Rachel and Keith Myers were present and provided a brief overview of the proposed development. One building with 4-6 townhomes to be located along Highway H. A playground will be installed, no pets allowed, no low-income housing (rent \$1500-1600 a month), and possibly 1 car garage and paved driveway. Residents approached the commission will comments such as but not limited to; traffic concerns, no guarantee the next owner does not make it low income, not a lot of commercial land available, bad location, short term rentals, small lot, and being close to railroad. There being no other comments, Mayor Heiliger closed the public hearing.

**<u>Rezoning 51.53 ± acres to "PDA-R" Planned Development Area – Residential</u> – Mayor Heiliger opened the hearing for comments relating to a rezone petition from Kylie Brown, Rezo House Buyers, LLC. Douglas Tiemann, Karl Schoenike and Kyle Brown were present. This will be a 134-lot development, including 3 different sized lots, homes and villas ranging from \$275,000 to \$490,000, and will have 6' side yards. The developer will preserve the middle of the development for common ground and detention basins. Residents approached the commission in favor for the development but had concerns regarding traffic along Westwoods Road, congestion at the Exit 200 overpass, and concern with trespassing and water flow onto neighboring properties. There being no other comments, Mayor Heiliger stated that the public hearing will remain open until the June 27<sup>th</sup> meeting when the Bill is presented to approve the rezone and the Preliminary Development Plan.**

**Conditional Use Permit – 105 North Mueller Avenue** – The Board reviewed Planning and Zoning's recommendation relating to a Conditional Use Permit to place a residential home on a lot located within the C-5 Downtown District. Mary Matyiko was present. The house is being moved from Foristell and will be set on a walk out basement foundation. They plan to sell the home and not rent it out. Scheiter Concrete Plant Expansion – 15920 Veterans Memorial Parkway – The Board reviewed Planning and Zoning's recommendation. Eric Kirchner and Pat Wessels were present.

Scheiter Concrete is looking to expand their plant parking lot for storying of recycled concrete blocks. Previously they proposed a 5-year paving schedule however, after feedback from the May workshop meeting, they are now proposing a 3-year schedule. Alderman Hakim moved to approve the 3-year concrete phasing exhibit as presented contingent upon a performance bond in the amount required by City Ordinances. **412 West Second Street North – Theresa Ellis** – The Board reviewed Planning and Zoning's recommendation to rezone the South side of West Second Street North from Roelker Road to 404 West Second Street North. Theresa Ellis is looking to subdivide her lot for the placement of a modular home. The property is currently zoned C-4 and residential of any type is not allowed. The Board did not want to rezone the property and would rather amend the C-4 requirements to allow for residential. This item will be discussed at the June Workshop

**403 West Second Street North – Sandra Boll** – The Board reviewed Planning and Zoning's recommendation to amend Chapter 405, Zoning Regulations, relating to the C-4 District adding Single-Family dwellings as an additional permitted use. This will allow Sandra Boll, the applicant, the opportunity to build a house on their empty lot.
