Parks – The department has applied to partner with the Major League Soccer program to have a partnership for youth soccer leagues. Summer Splash will be on July 13th from 1-4 pm at Diekroeger Park.

Public Works – Crack sealing has been completed in the Forest Lakes subdivision. The department will be marking areas on Wildcat Drive and Westwoods Road for repairs in the coming weeks.

Building Official – The bids for the 62-acre park phase 2 are still under review. Ameren will be changing a location for services and will reduce the total expense of the project by \$15,000-\$20,000. Mr. Strutmann will be visiting the 62-acre park tree line along the Spring Lakes Subdivision and make a recommendation on where trees need to be planted.

Police – The department has purchased two drones from donations received by Cuivre River Electric Cooperative and Russ Lyons and Family. A video demonstrating how the drones could be used was presented.

City Hall – The Board was reminded that National Night Out will be Tuesday, August 6th. With the 2023 Audit completion, Joy Howard has moved forward on the bond documents.

Treasurer – Ms. Hutchings has been preparing the six-month financial statement and helping with questions relating to the bonding process.
