Rezoning 51.53 ± acres to "PDA-R" Planned Development Area – Residential

*Held open from the May 23, 2024, Board of Aldermen Meeting- The Board of Aldermen held a public hearing on May 23, 2024, and the hearing was held open until the Preliminary Development Plan could be presented to the Board of Aldermen. Several residents of Carter Canyon expressed concerns relating to the emergency entrance that will connect to their subdivision with no plans for gates to prevent through traffic. Doug Rugh expressed concern with the density of the development. The developer, engineer, and home builder were present. They stated that after 100 homes are developed, the emergency access road is required from the Fire Department and that they would install gates with Knox boxes The amenities will be installed with phase 2 of the development. There being no other comments, Mayor Heiliger closed the public hearing.

Jeff Niemeyer, MoDOT – Jeff Niemeyer was present to provide an update on the I-70 project and to present a draft municipal agreement for review to access city Right-of-Way. It was announced that the final budget for the I-70 project from Wentzville to Warrenton will be \$565 million dollars. It was also announced that an additional \$40 million has been allocated to Wright City for construction of a new interchange east of the existing Elm Street overpass.

Bill 15-24— AN ORDINANCE TO ESTABLISH THE ZONING CLASSIFICATION OF THREE PARCELS OF LAND WITHIN THE CITY CONTAINING 51/53 ACRES, MORE OR LESS, AS "PDA-R" PLANNED DEVELOPMENT AREA RESIDENTIAL DISTRICT; AUTHORIZING AND DIRECTING THE AMENDMENT OF THE OFFICIAL ZONING MAP OF THE CITY; APPROVING A PRELIMINARY PLAT THERFOR; AND OTHER MATTERS RELATING THERETO. Ms. Ogborn read the Bill by title. Alderman Hakim moved to read Bill #15-24 a second time. Alderman Owens seconded it and the voice vote was as follows:

- 1) The existing street "Ali Way" to be extended North to the Warren County line and meet city specs;
- 2) A gate with a Knox box will be installed at the County Line and Ali Way. A gravel emergency access road will connect to the entrance of Serenity Woods where another gate with a Knox box will be installed;
 - ** A concrete approach will connect the county gravel road to the city streets.
- 3) Those gates will have clear signs that state Emergency Access Only;
- 4) Where the development borders Mary F. & Gene A Rugh Trustees property, a fence that meets city specifications will be installed on the property line;
- 5) Subdivision Amenities must be built before the completion of phase 2 and before the start of phase 3;
- 6) It is to be outlined in the CCR's that the common area is to include the gravel emergency access road and gates and is to be maintained by the developer or the Serenity Woods HOA.

Alderman Owens seconded it and roll call was taken with the following vote:
